**Tournament Rules**

1. **Safety First:** This is a recreational event. We are here primarily to enjoy each others company. Do not push your training limits or violate safe practice. The FSDA & the TBSC recommends that no competitors exceed the recreational diving limit of 130 feet.
2. **Officially Entered:** No diver is officially entered in the tournament until the TBSC has received a properly filled out Waiver, Registration, & all fees are paid.
3. **Spearfishing Tournament Dive Day: The Dive Day is Sat. April 9<sup>th</sup>, the rain date is April 16<sup>th</sup>. Diving begins at Dawn & ends at Dusk.** The rain date schedule will be the following week with the same times as the original date.
4. **Early Registration Ends: Friday, April 1<sup>st</sup> , 2011**  
All registration forms must be postmarked by this date or hand delivered on or before this date to Aquatic Obsessions Scuba, St. Petersburg, Florida.
5. **Early-Registration & Confirmation:** To confirm that a participant’s Early Registration form was properly received, each Early Registered participant should call (727) 344-3483 by **6pm, Wed. April 6<sup>th</sup>** . This confirmation will allow every Early Registered participant to rest assured that all his/her paperwork has been received and is in proper order.
6. **Late Registration: Starts at 7:00pm on April 8<sup>th</sup>** and is over at @ 8:30pm.  
This is the only date and time for Late Registration. If turning in a Late Registration for someone on your boat, please make sure every part of the Waiver and Registration form is properly and completely filled out (**No Exceptions!**)! The Late Registration will be held at: Aquatic Obsessions Scuba, 6193 Central Avenue, St. Petersburg, Florida 33710.
7. **Mandatory Diver’s Check In:** Every participant should be at the “Diver’s Check In” meeting; however, at least one Representative Diver from each boat must be at the “**Diver’s Check In**” meeting (to represent himself and those on his/her boat) to pick up mystery tickets, get any last minute rule changes, get the official tournament time and verify entry paperwork. Your buddy’s confirmation number is required to pick up any Early Registered participants paperwork at the “Diver’s Check In.” This “Diver’s Check In” will end with the beginning of the mandatory Captain’s Meeting.
8. **Captain’s Meeting starts** at approximately 8:30pm.  
The Late Registration, the Diver’s Check In and the Captains Meeting will all be held from 7:00 to 8:30pm on Friday **April 8<sup>th</sup>** . This meeting will be held at: Aquatic Obsessions Scuba, 6193 Central Avenue, St. Petersburg, Florida 33710. For directions, see map quest or call (727) 344-DIVE (3483).
9. **Mystery fish tickets:** Each participant will receive ONE (1) mystery ticket. The ticket will allow a competitor a chance to win one of the prizes donated by the Tournament Sponsors. These prizes will be awarded immediately after all the tournament trophies have been distributed. These prizes are a bonus for the participants and the amount and type of prizes is dictated by the generosity of our Sponsors. These are randomly picked drawings. All participants have an equal chance to win a prize. Participant must be present to accept a prize. A Prize pick is never guaranteed for each and every person that participates. In all the past years we have had at least one prize worth no less than \$25 for each participant at the prize pick. We hope to be able to continue this trend.

10. **Points:** The participant must choose which fish to weigh, the officials cannot weigh your fish, individually, to determine, for you, which fish are the largest to turn in to the tournament. A diver will receive one (1) point per pound and five (5) points per fish weighed. There is a limit point value per fish of 20 points for weight and the Five (5) points awarded for the fish, with a maximum total point limit per fish of 25 points. Ties will be broken by dividing the diver's total fish weight by the number of fish – the higher score wins. Lionfish receive only five (5) bonus points per fish weighed.
11. **Weigh-in:** The weigh-in will take place on **Sunday, April 10<sup>th</sup>** at the **Winghouse Bar & Grill, 7790 US Hwy. 19, Pinellas Park, Florida 33781, their phone is (727) 547-9464**. All participant's fish must be in the weigh-in line **no later than 12:00PM (Noon), No Exceptions**. Bring your coolers to the back of the weigh-in line. Weigh-in will open at approximately 10:30AM.
12. **Prizes & Awards:** Trophies and prizes will be awarded on **Sunday**, immediately after the weigh-in, and when the computer computations are completed. **First place** finisher (the person with the highest aggregate score) will get the 1<sup>st</sup> Place trophy and the subsequent **next four top-finishers** will receive trophies for second through fifth place. Trophies will also be awarded for the **Largest** of each fish category, the top aggregate scoring **Junior**, top **Female**, and the top **Freediver**.
13. **Eligibility:** Both men and women divers are welcome to participate. Divers under the age of 18 **MUST** have a signed release from their legal guardian. **No Diver is officially entered** in the tournament until the TBSC has received a properly filled out Waiver, Registration, and all fees have been paid. **All divers, except Juniors, must be current FSDA members. The \$20.00 FSDA dues for 2011 can be paid with a diver's registration. Note: Paying the FSDA \$20 fee at this tournament will also cover your FSDA \$20 fee for the State of Florida Freedive Tournament on April 15, 2011 and the Southern Open Spearfishing tournament (State of Florida Spearfishing Championship) in June, 2011.** Junior Division (ages 12-17) are guests of FSDA and exempt from FSDA membership requirement.
14. **Registration:** To properly register for this tournament, turn in the completed Registration form (page 2 of 5) along with the Waiver (first page) & payment.  
**Early Registration Ends: April 1<sup>st</sup>, 2011**  
All registration forms must be postmarked by this date or hand delivered on or before this date to Aquatic Obsessions Scuba, St. Petersburg, Florida.  
**Late Registration:** The only date and time for late registration is, Friday **April 8<sup>th</sup>, 2011**, from 7:00pm to 8:30pm at Aquatic Obsessions.  
***A special discounted rate is offered for youth participants, as well as all those who register early. And anyone who does Early Registration gets a FREE Tournament Collectors T-shirt (see the registration form for details).***  
All spearfishing competitors must possess a valid Florida salt water fishing license. **Mail Registration form and Waiver**, along with your check or money order (please don't mail cash) made out to:

15. **Junior Division:** Divers 12 to 17 years old shoot in the normal portion of the tournament, but they are also entered into the competition for the top Junior shooter. Junior competitors must be certified divers and have a signed release from their parent or guardian. Just like the Adult participants, all Junior participants should not exceed any depth or dive in any conditions that they are not trained or certified to dive. All Junior shooters should be properly supervised by an Adult. Minimum age to enter this tournament is 12 years old.

**FISH DONATION:** We will be collecting donated fish for our Charities. Two tickets will be given for each Grouper, Hogfish and Snapper donated, and **One ticket** for each of the others donated. We will supply a nice prize to be awarded to the participant with the winning ticket. The prize will be exhibited at the Captain's meeting and the weigh-in.

17. **All fish: All participants must follow and abide by all local, State and Federal**

**laws.** All fish must be legally taken and landed by the diver who is awarded the points, and brought to the scales before the close of the tournament. Powerheading of fish is not allowed. The "Weigh-in Line" will constitute the physical location for the close of the meet. **All fish must be physically in the weigh-in line by 12:00 PM.** All competitors' fish must be presorted, fully and properly gutted, on individual stringers, and on ice. All fish turned in must be in a fresh and whole condition and have all appearances of freshness. Fish that are shorter than Federal/State size regulations or that do not appear to be well iced and look fresh as per the judgment of the tournament Weighmaster, cannot be weighed, or if already weighed it can be disqualified. Only one participant of a tournament boat is required to weigh-in the fish for any fellow members of his boat. If a participant is weighing-in fish for a boat buddy, he must know the buddy's entry number and full name. If you elect to shoot Barracuda and/or Lionfish, you must properly remove & utilize the fish or you will be disqualified, no exceptions.

18. **Disqualification** is automatic for latecomers. Any cases of cheating will result in a disqualification. Presenting a fish for weigh-in, that is less than the minimum eligible size, is cause for automatic disqualification of that diver from the tournament. The Official Time shall be announced at the Friday Captain's Meeting and kept by the TBSC President. Latecomers (who wish to have their fish weighed-in for club tournaments) can have their fish weighed at the end of the official weigh-in, but only with the TBSC President's approval. To remove any misunderstanding for bystanders, the coolers holding these late fish, will have a large red X placed on top of the cooler with Red Tape.

19. **Protest:** Any diver may file a protest with the TBSC President or TBSC Vice President. Any protest must be filed before the start of trophy issuance. A **Protest Committee** will be made up of these current TBSC officers: TBSC President, the TBSC Vice President, the TBSC Secretary, and the TBSC Treasurer. All Protest Decisions will be made in a timely manner and **all decisions will be final.**
